"environmentally friendly"; d) 3G "more than one lot requires consolidation"; e) 3M add "unless removed from property"; f) 3O – "in no case shall..." should read "no encroachment"; g) 3Q – hyphenate "off street"; h) 13A change "each to "an"; i) 13A – for "an" ADU; j) 13B – add "and passed" at end of sentence; k) 16 – change "had not been" to "were not". Trustee Cindy Simpson made the motion to approve Ordinance 725 Series 2017 Making Certain Amendments to the Land Use Code of the Town of Mancos Concerning Accessory Apartments and Accessory Dwelling Units within Town Limits of the Town of Mancos, Colorado with the suggested changes by Trustee Simpson. Trustee Michele Black seconded the motion. Motion passed unanimously by roll call vote.

3. Ordinance 730 Series 2017: Lot Consolidation Western Excelsior
Town Attorney David Liberman suggested removing "preliminary" from the plat map. He also suggested "Town Council" be changed to "Town of Mancos Board of Trustees" and the referenced loan holder, Old National Bank, in the title commitment needs to have a signature block on plat to prove consent. Trustee Cindy Simpson made the motion to approve Ordinance 730 Series 2017 Approving Lot Consolidation for Western Excelsior Corporation and Accepting the Amended Plat of Amended Plat Block 3, Block 6 and Vacated Streets and Alleys Shown in Reception #565773 Records of Montezuma County, Colorado with the changes recommended by Town Attorney David Liberman. Trustee Michele Black seconded the motion. Motion passed unanimously by roll call vote.

- 2. Appointments to Planning & Zoning Commission

  Trustee Lorraine Becker made the motion to re-appoint Perry D. Lewis, Regina Roberts and John Cox to serve as regular members of the Planning and Zoning Commission with terms ending in April of 2020. Mayor pro tem Fred Brooks seconded the motion. Motion passed unanimously by roll call vote.
- 3. <u>Public Hearing: Ordinance 728 Series 2017: E. Second Street Vacation & Replat Public Hearing opened at 8:23 p.m.</u>
  - <u>Kathryn Fulton</u>, 39850 Road J, <u>Mancos</u> speaking against Town has allowed encroachment without compensation under Reception #534249, she questions why the Town is willing to give land away. Town Administrator Andrea Phillips advised she is aware of the encroachment and did require the

- fence be moved several years ago. Information will be brought to a future meeting.
- Basil Richendollar, 233 Aztec, Mancos speaking for wants it done for his daughter's safety due to vehicular traffic. He also feels that it is a half street and not maintained by the Town. He has photos of the area and neighboring property.
- Randy Smith, 212 Montezuma, Mancos speaking against 2<sup>nd</sup> Street dead ends at his property. He paid for a permit 22 years ago to build his shop on his property. He stated all property owners park in the easement. He deserves to have full access to the fire hydrant for safety reasons. He has not been included in this replat discussion. He is against the Town giving away land.
- Bobbie Mykytiuk, 305 Aztec, Mancos speaking for when she moved in it was used as access to sheds on the property. She advised that when Mr. Smith moved in, he didn't use this access until he built his shop. She feels Mr. Smith's complaints led to the Town requiring removal of her fence, which she did at her expense.
- Evan Richards, 156 Sunset, Mancos speaking against he feels that this sets a precedent if someone doesn't like his/her neighbor, they can lobby the Town of Mancos to close a street, he feels this is a neighbor conflict, he is also against giving away Town land.
- Kevin Cook, 257 S. Main, Mancos speaking against doesn't have a stake
  in the neighbor dispute, feels that Town shouldn't give property away to two
  property owners to the exclusion of the third neighbor as this causes
  injustice, doesn't feel the vacation should be used to solve neighbor disputes
- Betsy Harrison, 895 2<sup>nd</sup> Ave, Mancos speaking against she agrees with Kevin Cook, it sets a bad precedent, she agrees with Kathryn Fulton that the Town shouldn't give land away

Public Hearing closed at 8:59 p.m.

Town Attorney David Liberman advised that the Town does have authority to abandon streets, but is under no obligation to abandon this street. He doesn't think this sets policy as requests are decided on a case by case basis. This plat does allow access by Mr. Smith to his shop. In prior abandonments, Town has received consideration, but there's no requirement under statute. The Board feels this is a neighbor dispute that won't be solved by this vacation. Application failed due to lack of motion. The Board instructed Staff to identify the right of way and remove all encroachment.

4. Resolution 7 Series 2017: Downtown Parcel Lease Agreement and Sidewalk 50/50 Project

The existing mural fence will be removed and given to the Town. Trustee Lorraine

Becker made the motion to pass Resolution 7 Series 2017 Approving the Agreement between the Town of Mancos and Ruedi Bear to Enter into a Downtown Parcel Lease for a Temporary Pocket Park and authorize the expenditure of town funds not to exceed \$2,250 towards the replacement of sidewalks in front of the property per the town's 50/50 sidewalk program. Trustee Cindy Simpson seconded the motion. Motion passed unanimously by roll call vote.

Trustee Michele Black made the motion to authorize town staff to purchase the Pressure Reducing Valve Vault from isiWest at a cost not to exceed \$90,710.00 for the Water System project. Mayor pro tem Fred Brooks seconded the motion. Motion passed unanimously by roll call vote.

### 8. Trustee Benefit Options

All Trustees are eligible to receive the group rate for medical, dental, vision and life insurance at their own expense. Trustee Cindy Simpson made the motion to allow Trustees to apply for insurance through the Town of Mancos and CEBT and require Trustees to pay their premiums to the Town Clerk by the 1<sup>st</sup> of each month if they so choose. Trustee Michele Black seconded the motion. Motion passed by roll call vote with Mayor pro tem Fred Brooks abstaining.

### 9. Town Clean Up & Yard Waste Drop Off

Annual town clean up has been scheduled for May 19 and 20 from 8:00 a.m. to 5:00 p.m. at the Public Works Shop on S. Monte. The free monthly yard waste drop offs begin May 20 from 8:00 a.m. to noon on the third Saturday of each month through October.

## 10. Sewer Line Replacement On Montezuma Ave.

Trustee Michele Black made the motion to authorize the expenditure of funds from the Water System Project budget for replacement of up to 740 linear feet of sewer collection main on Montezuma Avenue, authorize Mayor Barz to sign the request letter to the Department of Local Affairs and amend the contract with Ramco Developments, LLC after DOLA approval. Trustee Lorraine Becker seconded the motion. Motion passed unanimously by roll call vote.
