1. 2016 Financial Audit

2. Columbine Inc. Liquor License Renewal

Trustee Ed Hallam made the motion to approve the Columbine Inc Liquor License Renewal and authorize the Town Clerk/Treasurer to submit the renewal application to the Dept. of Revenue. Trustee Cindy Simpson seconded the motion. Motion passed unanimously by roll call vote.

3. Mancos Marshal's Office Reallocation of Funds

In 2015, the Town of Mancos paid \$10,000 to the City of Cortez for the Caviness Mountain DTR project. This money was not needed for the project and has been refunded to the Town. Marshal Jason Spruell is requesting reallocation of a portion of

these funds to cover the increase in the 2017 Cortez Dispatch bill in the amount of \$5,794. He is also requesting \$2,825 to purchase two new radar units. Trustee Cindy Simpson made the motion to reallocate \$5,794 to assist with dispatch bill from City of Cortez and \$2,825 allocated to two new radar units as specified by staff in the staff report with balance going to General Fund these funds. Trustee Michele Black seconded the motion. Motion passed unanimously by roll call vote.

4. Town Beautification Update

Parks Manager Terry Jennings presented an update to the Board with regard to downtown flowers and weed management.

5. Special Use Permit Revisions
