Mancos Volunteer Fire Dept. Fireworks Donation Request
Brandy Goff and Kaylee Rose were present on behalf of the Mancos Volunteer Fire Dept. to
request a contribution to the annual fireworks fund. Trustee Lorraine Becker made the motion to
authorize the donation of up to \$1,500 to the Mancos Volunteer Fire Dept. for their 2017 Fourth
of July fireworks display. Mayor pro tem Fred Brooks seconded the motion. Motion passed
unanimously by roll call vote.

## 2. Resolution 10 Series 2017: Temporary Burn Ban Lift

 Gina Roberts, 601 Grand Ave., Mancos – read a prepared statement in favor of lifting the burn ban

This resolution temporarily lifts the burn ban to allow for the controlled use of fires in outdoor fire pits to allow the Board time to review this topic in depth and recommend changes. It also allows the Mancos Fire Dept. to put on their fireworks display on the 4<sup>th</sup> of July each year without having to pass a resolution every year. Trustee Michele Black made the motion to approve Resolution 10 Series 2017 A Resolution Temporarily Lifting The Mancos Fire Ban To

Allow For Controlled Open Fires Within town Limits And To Allow For Controlled Fireworks Displays By The Mancos Fire Department Within Town Limits During July 4 Of Each Calendar Year and adding a ban when a Red Flag Warning is in effect. Trustee Cindy Simpson seconded the motion. Motion passed unanimously by roll call vote.

### 3. Park Structures Paint Quote

Trustee Michele Black made the motion to authorize Parks Manager Terry Jennings to enter into an agreement with Fredericks Custom Coatings to refurbish the pavilions in Boyle Park at a cost not to exceed \$1,700, and allocating \$1,000 from the 2017 General Fund budget and \$700 from Conservation Trust Fund reserves. Mayor pro tem Fred Brooks seconded the motion. Motion passed unanimously by roll call vote.

# 4. Planning Commission Chair/Co-Chair Appointments

This item was discussed at the May 17, 2017 Planning Commission meeting with regard to electing the Chair/Vice Chair of the Planning Commission. Our code currently requires the election of the Chair/Vice Chair at the first meeting of each calendar year. Planning Commission member terms run through April. The Board directed Staff to move forward with this change.

## 5. WWTP Ultrasonic Flow Meter

Trustee Ed Hallam made the motion to authorize the purchase of an ultrasonic flow meter for the wastewater treatment facility and related equipment at a cost not to exceed \$2,874.70 per the 2017 budget. Trustee Cindy Simpson seconded the motion. Motion passed unanimously by roll call vote.
