J. UNFINISHED BUSINESS

- 1. Ordinance 740 Series 2018: Changes to Planning Commission
 - Gina Roberts, 601 Grand Ave. Mancos, CO has several concerns with the proposed ordinance: a) agrees that alternates should be required to and paid to attend; b) doesn't agree with reducing the number of members from 5 to 3; c) doesn't agree with ex officio members voting as this doesn't keep the entities separate; d) how is a tie broken if an ex officio member is not present; e) does not feel it's fair that if a special meeting is missed, members aren't paid; f) how will an absence be determined to be justified.

After discussion, Mayor pro tem Fred Brooks made the motion to Approve Ordinance 740 Series 2018 An Ordinance Making Certain Amendments To The Mancos Municipal Code Concerning The Planning and Zoning Commission. Trustee Craig Benally seconded the motion. Motion passed unanimously by roll call vote. All Planning Commission members will be asked to reapply for the commission.

2. Land Use Code Project Update

The Town of Mancos has contracted with SAFEbuilt to review and update our land use code. Attached is a draft schedule for this process. SAFEbuilt will be in

Mancos on April 17 and 18 to begin the stakeholder outreach meetings. April 17 will be held at the Community Center, April 18 will be held during the Planning Commission meeting. SAFEbuilt is also working on getting the project website up to begin soliciting comments and feedback. Each of the comments, regardless of how they are sent to the Town, will be tracked by SAFEbuilt.

3. Main Street Bridge Update

The Town of Mancos has contracted with Russell Engineering for the design and engineering of the Main Street Bridge. Currently, the rights of way history is being reviewed and confirmed by Farnsworth Group. Maness and Associates is conducting a survey of the location to be sure the bridge is constructed entirely in Town right of way. The geotechnical report and topographic survey are completed and being reviewed by Russell Engineering. The drainage study is currently underway. Currently under discussion is potentially lengthening the bridge from 45' to 50' to the south with the goal of achieving compliance with ensuring the 100 year flood flow under the bridge. This decision will also influence potential design options. Next steps include a scoping meeting with CDOT regarding right of way and potential environmental issues. This has been delayed due to their current computer issues. As the surveys are completed and engineering moves forward, workable design options will be brought to the Board for discussion.

1. REDI Grant & Economic Development Strategy Application

Trustee Ed Hallam made the motion to authorize the Town Administrator to apply for a Rural Economic Development Initiative Grant, and, if approved, execute the contract. Trustee Cindy Simpson seconded the motion. Motion passed unanimously by roll call vote.
