Town of Mancos Board of Trustees Meeting June 27, 2018 7:00 p.m.

A. CALL TO ORDER: Mayor Queenie Barz called the meeting to order at 7: 04 p.m.

B. PLEDGE OF ALLEGIENCE & MOMENT OF SILENCE

- **D.** APPROVAL OF AGENDA: Mayor pro tem Fred Brooks made the motion to amend the agenda by adding Riverwood RV Park as item #2 under unfinished business. Trustee Betsy Harrison seconded the motion to approve the agenda. Motion passed.
- E. APPROVAL OF THE MINUTES OF June 13, 2018: Trustee Cindy Simpson made the motion to approve the minutes of June 13, 2018 with the correction from Mayor Queenie Barz to Mayor pro tem Fred Brooks as signature because he chaired the meeting. Trustee Brent McWhirter seconded the motion to approve the minutes. Motion passed.

F. AUDIENCE BUSINESS

1. <u>Casey Simpson, Four Corners Recycling Initiative</u> – discussed the recycling issues in Mancos. The bins are constantly overflowing and causing a problem. Asked the Board to consider taking the lead to assume ownership as 4CRI doesn't have the resources to manage. The Board suggested approaching the Mancos Valley Chamber with this information and asked Staff to research possible solutions to bring to a future meeting.

G. DIVERSION RATES/LANDFILL DISCUSSION – SHAK POWERS

Mr. Powers presented information to the Board regarding recycling and updates to the Montezuma County Landfill.

H. ANNOUNCEMENTS

1. Code enforcement planning process has begun. We are working on finalizing the Town Clean Up weekend, then public education and information will begin.

J. UNFINISHED BUSINESS

1. Resolution 10 Series 2018: Watering Restrictions

After discussion, the resolution will be amended to state the Mancos Water Dock may be closed or hours and use limited. Trustee Cindy Simpson made the motion to approve Resolution 10 Series 2018 A Resolution Implementing Watering Restrictions For All Tapholders Connected To The Mancos Municipal Water System with the above amendment. Trustee Ed Hallam seconded the motion. Motion passed unanimously by roll call vote.

2. Riverwood RV Park

Dugan McDonald was present at this meeting. He stated the items in the development agreement are complete. He advised that the metal building will take several more months to complete. He requested to be allowed to open the park by July 4, 2018 because he has taken reservations. Staff advised that all items are not complete based on the development agreement, plans on file with Town Hall and the Mancos Municipal Code. The Town is not able to issue a temporary Certificate of Occupancy as there is nothing in the Mancos Municipal Code that allows this. After discussion, the following decisions were agreed upon by Mr. McDonald and the Board of Trustees:

- a) Screening from the approved screening list will be installed along the south and west sides of the property per Mancos Municipal Code. All screening installed will grow to at least 6' in height.
- b) Metal building will be constructed to existing standards and inspected. Mr. McDonald advised it will be used for habitation. Electrical and plumbing inspections will be performed by the State of Colorado per State law.
- c) Concrete pads around RV sewer hookups will be round instead of square.
- d) Sign application will be submitted and approved by Town staff.
- e) The development agreement will be extended to August 31, 2018 per Mr. McDonald's request.
- f) Mr. McDonald will submit his request to the Board in writing for the July 11, 2018 Board meeting.
- g) This item will be placed on the July 11, 2018 agenda for further discussion and decision between Dugan McDonald and the Board of Trustees.

Trustee Cindy Simpson made the motion to extend the existing development agreement to August 31, 2018, the screening along the south and west sides of the property will be installed per the Mancos Municipal Code, the sign permit application will be submitted and approved prior to issuance of a certificate of occupancy, the metal building will be constructed to existing standards and inspected, the concrete pads around the RV sewer hookups called out on the plans will be amended to 24" round, and this item will be brought to the July 11, 2018 meeting to discuss the amendments to the development agreement. Trustee Betsy Harrison seconded the motion. Dugan McDonald agreed that these items are correct. He is requesting the metal building be removed from the development agreement and processed under a separate building permit to allow him to open the park without this item being completed. Motion passed by roll call vote with Trustee Ed Hallam abstaining.

K. NEW BUSINESS

1. <u>Planning Commission Alternate Member Application – Tiffany Hurst</u> Upon recommendation of the Planning Commission, Trustee Ed Hallam made the motion to approve appointment of alternate Tiffany Hurst to the Planning Commission. Trustee Craig Benally seconded the motion. Motion passed unanimously by roll call vote.

2. Mancos Chavolo's Mexican Restaurant Liquor License Renewal

Trustee Ed Hallam made the motion to approve the renewal of the Mancos Chavolo's Mexican Restaurant Inc. Liquor License and authorize the Town Clerk to send the application to the State. Trustee Betsy Harrison seconded the motion. Motion passed unanimously by roll call vote.

3. Resolution 11 Series 2018: 59th Annual Mancos Days

Trustee Cindy Simpson made the motion to approve Resolution 11 Series 2018 A Resolution Supporting The 59th Annual Mancos Colorado Days And Encouraging The Citizens Of Mancos To Participate. Mayor pro tem Fred Brook seconded the motion. Motion passed unanimously by roll call vote.

4. 2nd Quarter 2018 Work Plans

Work Plan updates were presented to the Board for review. No comments were presented.

5. CIRSA Safety Award

Mayor Queenie Barz was presented with a Loss Prevention Award for Workers' Compensation for the Town of Mancos at the CML conference.
