H. PRESENTATION – MONTEZUMA LAND CONSERVANCY/TRAVIS CUSTER Mr. Custer offered an update to the Board on the recent projects of the Montezuma Land Conservancy. They have approximately 46,000 acres in conservation easements in Montezuma, Dolores and San Miguel counties. They are the fiscal agent for the Montezuma Inspire Coalition. They have provided about 75 jobs for high school students. MLC presented at the 2019 National Land Conservation Conference, and they are currently working with CSU, Fort Lewis and SWOS on a water conservation program.
