K. ACTION AND DISCUSSION ITEMS:


1. Ordinance 763 Series 2021: Watering Restrictions: Trustee Cindy Simpson made the motion to Approve Ordinance 763 Series 2021 An Ordinance Amending Section 13-1-330(d) with Regard to Step 3, To the Town of Mancos Municipal Code Concerning Wasting Restrictions And Violations And Declaring An Emergency. Trustee Betsy Harrison seconded the motion. Motion passed unanimously by roll call vote.
2. Dispatch IGA Approval and Authorization: Staff is requesting this item be tabled until such a time as it is signed by the City of Cortez Council. Current dispatch budget will be added to the next packet.
3. Yard Waste Drop Off & Town Cleanup Fee Discussion: Currently, the Town of Mancos offers free monthly yard waste drop off (during the spring and summer months) and free bi-annual Town clean up days without residency restriction. Staff provided an estimated cost of \$12,160 annually for these services. The Board agreed to leave it free of charge for 2021 but discuss further in a workshop when additional information is provided.
