I. DISCUSSION ITEMS

1. Mancos Conservation District Re-Plat

The Mancos Conservation District is considering splitting their existing lot into two parcels. The north lot would be developed with a duplex. They are requesting direction from the Planning Commission on several items. A possible solution is to bring the north lot immediately into compliance by removing the existing shed, applying for a special exception for the main building on the south lot and offering temporary approval for the

This shed is currently being used for storage for the School To Farm items while the School Garden is unavailable. Staff will work with the Mancos Conservation District on this item.

- Section 2.2 How We Live clarification needed to define "total housing units" to include apartments, ADUs, vacant lots, etc.
- Mancos Employment Percentages By Industry can we separate commuters vs non-commuters by industry to outline how many people are living and working in Mancos? Track down the report to the Mancos Chamber by Joe Keck
