- Tony Aspromonte, 899 Bauer Ave, Mancos spoke against Lots 1 & 2 on the preliminary plat. His concern is that the north lot line of Lot 2 will impose a side setback rather than a full rear setback. This should be a 4 lot subdivision.
- <u>Tim Hunter was present on behalf of EM Management LLC</u>. He answered questions regarding setbacks, access concerns, easement access.

Public Hearing closed at 8:00 p.m.

Commissioner Peter Brind'Amour made the motion to approve the preliminary plat for 862 Grand Ave with the following conditions: 1) Lot 2 north side setback will be 25' from the property line, and 2) All requirements of the final plat will be provided to the Town prior to scheduling a public hearing before the Board of Trustees. Commissioner Cathy Seibert seconded the motion. Motion passed unanimously.
