2. 2009 Mancos Source Water Protection Plan Discussion

This document was prepared in 2009 by the Colorado Rural Water Association for the Town of Mancos, Mancos Rural Water and Mesa Verde National Park.

Possible questions to address/consider:

- 1. Is the document still relevant? After lengthy discussion the Commission decided it was relevant, stats should, of course, be updated. It would be a good idea to review the document annually. Copies of the water quality report are available annually on the town web site and in Town Hall. Do we test water at the source? Does the Water Conservency district test the source water? "Mancos Water Group" driven by BLM, CO State Resources, local irrigators, Forest Service, Ute Mountain Park, and Jackson Lake has met for discussions. The Town of Mancos tests and treats the Town water daily.
- 2. Do we want to reach out to Mancos Rural Water and Mesa Verde National Park for a joint discussion? Yes, as well as those listed below.
- 3. Do we want to include any other water agencies (Mancos Conservation District, Gary Kennedy, Montezuma County, etc.) in these discussions moving forward? Yes, and contact Gretchen Rank with the Conservancy District first-they have been working on this topic for some time and we could have a joint effort. Protect Jackson Lake from fire concerns and sediment. (Gary Kennedy would address this) Fire concerns- block intakes. Include Jim Spratlen, Montezuma County Emergency Manager and the U.S. Forest Service
